Innovations in SME financing 23 November 2018, Bordeaux (France)

The last Workshop in Quantitative Finance, Risk and Decision Theory, "Bank Risk and Firm's Financing", has confirmed that SME financing could be at risk due to banks portfolio reallocation following new prudential regulations. This risk has led European authorities, among others, to support innovation and research in order to reduce the dependency of SMEs on bank financing. This process has led to the development of new financial participants, products or techniques. New categories of lenders have appeared, with the development of crowdlending, micro-credit for SMEs by e-commerce platforms, public lending and collateral institutions such as the BPI (Banque Publique d'Investissement) in France have been developed. Banks have experimented new structures or organizations in order to enhance their support of SME growth. New proxies for credit information or SME risk measurement are developing to take into account these new forms of financing. New financial markets dedicated to small caps have been launched, experimenting new forms of support of listed SMEs by listing sponsors or dedicated organizations such as Enternext in France.

The 3rd International Bordeaux Workshop in Quantitative Finance, Risk, and Decision Theory aims to focus on those innovations. The following non-exclusive topics are considered:

- New advance in SMEs risk assessment
- Crowdfunding, crowdlending platforms
- SME support by banks or institutions, innovations and growth
- Limits in SME financing
- New prospects in private equity
- Entrepreneurship
